Cleansing notice under section 708A the *Corporations Act 2001 (Cth)*

On 8 June 2017 Adherium Limited ACN 605 352 510 (**Company**) (ASX: ADR) announced the exercise of options and the resulting issue and allotment of 150,000 fully paid ordinary shares in the capital of the Company (**Shares**) at the issue price of \$0.134039 per Share. The Company also applied for quotation of the Shares on ASX.
